



DESCRIPTION/ORDERING INFORMATION

This single 2-input positive-NOR gate is designed for 1.65-V to 5.5-V V_{CC} operation.

See mechanical drawings for dimensions.

The SN74LVC1G02 performs the Boolean function $Y = \overline{A + B}$ or $Y = \overline{A} \cdot \overline{B}$ in positive logic.

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using I_{off} . The I_{off} circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.






Figure 1. Load Circuits and Voltage Waveforms






