## DESCRIPTION


This single 2-input exclusive-OR gate is designed for 1.65-V to 5.5-V  $V_{CC}$  operation.

The SN74LVC1G86 device performs the Boolean function  $Y = A \times B$  or  $Y = \overline{AB} + \overline{AB}$  in positive logic.

A common application is as a true/complement element. If the input is low, the other input is reproduced in true form at the output. If the input is high, the signal on the other input is reproduced inverted at the output.

NanoFree<sup>™</sup> package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{off}$ . The  $I_{off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.





## **Exclusive-OR Logic**


An exclusive-OR gate has many applications, some of which can be represented better by alternative logic symbols.



These are five equivalent exclusive-OR symbols valid for an SN74LVC1G86 gate in positive logic; negation may be shown at any two ports.



The output is active (low) if all inputs stand at the same logic level (that is, A = B).



The output is active (low) if an even number of inputs (that is, 0 or 2) are active.



### Figure 1. Load Circuit and Voltage Waveforms






